

**The project « Intercultural dialogue and civic participation against stigmatization of migrants and refugees - FORUM » was funded with the support of the European Union under the Programme "Europe for Citizens"**

**Applicable to the Strand 2 – Measure 2.3 "Civil Society Projects"**

**Preparatory activities** (if applicable): **Activity 1:** Kick-off Meeting. It involved 12 participants; **Activity 2:** Roundtable. In the Frontline: Migrant women in the COVID19 context in Europe. It involved 50 participants.

**Location / Dates:** Online / 21-22 April 2021

**Short description:** **Activity 1** consisted in a Kick-off meeting organised by coordinating partner CICODE. It counted with the participation of all project partners' representatives. This event represented a unique opportunity to define a common ground for the consortium and share expertise as well as project expectations. **Activity 2** consisted in an online public project presentation, which included a roundtable, about how migrants, especially women, have been at the forefront facing the difficulties caused by the COVID-19 pandemic. Migrant women have carried out essential jobs and in this situation they are exposed to serious risks such as: labour exploitation, precarious work increase and unemployment; a greater risk of COVID-19 infection due to the difficulty of accessing to personal protective equipment in their jobs; a increase of populist anti-immigration discourses, racism and stigmatization. For all these, it is essential to analyze this reality with a gender and intersectional approach that allows identifying these inequalities, offering greater protection and support, and ensuring access to rights for migrant women.

**62** events have been carried out within this project:

**Event 1: Conference - Stigmatization of minorities, migrants, refugees and asylum seekers**

The six sessions developed the theories and procedure on migration giving a frame of reference for the situation of women. Topics such as governance and migration and asylum policies in the EU and Spain; weaving networks for political participation of migrant women in Granada; the industry of migration control; the logics of racism; feminist analysis of violence in the borders; and african women and human rights in Andalucía, were discussed.
